**ORDER**

As per the letter read as 1st paper above, Government have authorized the Commissioner, Disaster Management to recruit suitable candidates for contractual posts in the Kerala State Disaster Management Authority through the Centre for Management Development (CMD), Thiruvananthapuram. KSDMA called off the earlier notifications viz. notification no. SDMA/DM/596/2019 dated 21.05.2019 and notification no. SEOC/238/2019/SDMA dated 20.6.2020 and the information was published in the website of KSDMA. As per the letter read as 2nd paper above, the Member Secretary, KSDMA had communicated to the Commissioner, DM, the posts and vacancies to which recruitment had to be carried out along with relevant Government Orders. Following the same, the recruitment notification read as 3rd paper above was widely published inviting applications for various contractual posts under KSDMA including the post of Consultant, Disaster Management, Niti Ayog Scheme while highlighting the cancellation of earlier recruitment notifications dated 21.5.2019



and 20.6.2019 as indicated above. As per the letter read as 4th paper above, the Director Centre for Management Development has communicated the rank list for recruitment to various contractual posts under KSDMA.

2) As per the letter read as 5th paper above, the Commissioner, Disaster Management has requested the Government to approve the rank lists submitted for the appointment of the selected candidates to various Technical and Administrative posts notified vide 3rd paper above.

3) Government have examined the matter in detail and are pleased to approve the Rank list for the post of Consultant, Disaster Management, Niti Ayog Scheme and to appoint the selected candidate on contractual basis in the concerned vacancy under Niti Ayog Scheme as detailed in the Annexure to this order, subject to the following conditions.

1. The validity of the Rank List will be one year from the date of this Government Order.
2. The Commissioner Disaster Management shall fix the Normal Time Functions and Emergency Time Functions. The services of the appointee should be beneficial to DDMA, Wayanad.
3. Monthly consolidated pay will be Rs.70,000/-
4. Period of contract is not renewable beyond the project period. Norms under the Niti Ayog Scheme shall apply.


